The GreenLink project and seminar

This GreenLink Mediterranean seminar is the major event of the INTERREG IIIBMedocc project GreenLink performing, from 2006, networking activities in the Mediterranean between a transnational sample of cities and regions that exchange experiences and elaborate exemplary pilot projects for the integration of town planning and environment/nature protection tools in urban boundary areas. The seminar is also held, looking forward to a capitalisation performance of the GreenLink experience through interregional cooperation EC programs.

The suburban areas of the Mediterranean are characterised by highly critical conditions, weakness of management, fully open positions (territories waiting to be used) and by degradation. The added economic values, essential to attract investments, often create procedures which do not pay enough attention to the risks for the environment and nature quality and which do not develop a preliminary base line recognition, a strategic vision and an integrated approach through a wise evaluation of the impacts. This condition reduces the competitiveness and produces a structural weakness of the global system of the metropolitan area. On the other hand the potentiality of these territories is very important and, if well exploited, can generate quite positive repercussions, considering the improvement of the suburban quality conditions, the level of global quality of the urban region and consequently its competitiveness and increased attraction.

The more qualified environmental values, needed by the city, are situated in the suburban peripheral areas, where there are also major pressures for development. On the other hand, many services, requested by the surrounding rural hinterland, can be delocalised from the inner urban areas, to the suburban and near hinterlands, avoiding interdependence stress. An obligatory platform of alliance between cities and rural hinterlands should lead to wise and integrated planning, needed for promoting innovative dynamic profiles in border urban systems, solving conflicts and tackling opportunities.

Seminar thematic sessions

1. NEW URBAN SPACES AND NATURAL AREAS

The relationship between urban physical extensions and open periurban areas, is recently concentrated on the question of preserving, improving and increasing natural and semi-natural values as components of urban space quality planning .

The GreenLink seminar is keen in acquiring further knowledge and experiences of significant cases focusing on the relationship between nature and city, and assess relevant realizations and experimentations.

2. NEW URBAN SPACES AND MARGINAL AREAS

The urban marginal areas exuberant development, among its visible consequences, determines loss of identity of open spaces. The loss of the agricultural function, the dismissal of industrial areas, the disused railway areas are the most common ingredients of such phenomenon.

The GreenLink seminar aims to acknowledge innovative solutions experimented with either plans or projects, towards the realization of new urban landscapes.

3. NEW URBAN SPACES AND PERIURBAN PARKS

The realization of large periurban parks, still today as a lasting tradition, contributes to guarantee a correct relation between built space and open space in complex urban systems.

The GreenLink seminar intends to investigate and acquire knowledge on the most recent trends regarding periurban park designs, projects and realizations in strongly urbanized contexts.

4. NEW URBAN SPACES AND CONNECTIVE SYSTEMS

The open spaces systems reticular and connectivity theme, in periurban environments, represents one of the most recent trends for urban quality renewal.

The GreenLink seminar intends to present some significant experiences of redesigning periurban space through the valorisation of water courses, bike and pedestrian lanes, small size green spaces.

Regulation

- 1.** This Mediterranean Seminar is co-financed by the European Initiative Program INTERREG IIBMedocc, in the framework of the GreenLink project activities.
- 2.** Authors can submit one or more Paper drafts, corresponding to one or more seminar thematic session and concern recently realized or designed cases.
- 3.** The Scientific Committee will evaluate the Paper drafts and will select the Papers for publication in the proceedings of the Seminar, inviting authors to submit final Papers.
- 4.** Authors of selected Papers for the proceedings will submit the final Paper, following common, ready for print format and template, that will be communicated by the scientific committee.
- 5.** The scientific committee will select final Papers to present during the Seminar.
- 6.** Authors of Papers selected for the proceedings will be reimbursed for travel and subsistence expenses for participation to the seminar in Florence. (NB. EC ERDF Regulations will be applied for control of travel expenditures).
- 7.** Authors of Papers presented in the Seminar will receive a fee of 500Euros, including all taxes.
- 8.** Payments will be operated by bank transfer to the authors, following submission to the organizer, within the deadline of 6 June 2008, of: a) IBAN and SWIFT bank reference, b) fee invoice and c) original documents of expenditures, including boarding passes. Bank transfers can be operated within the 30 June 2008.
- 9.** Papers and power points should be submitted in English language.
- 10.** Papers and power point documents will be used by the organizer for purposes of publication and dissemination to Mediterranean cities in the framework of the GreenLink INTERREG IIBMedocc project.
